**From Thaw**

1. Place frozen Breadsticks on a parchment lined sheet pan. Cover and leave in refrigerator until ready to prepare. Product can be held under refrigerator for up to 3 days.
2. Preheat convection oven to 350 °F (conventional oven to 375 °F).
3. Uncover Breadsticks and place in oven.
4. Bake Breadstick 4–6 minutes. **Note: cooking equipment, equipment settings, and kitchen conditions will vary so cooking time may need adjusting. Cook all food thoroughly to 165 °F.**
5. Remove from oven. Serve.
6. Holding: Hold for up to 30 minutes in a warmer at 145 °F.
