From Frozen

- 1. Preheat convection oven to 350 °F (conventional oven to 375 °F).
- 2. Place frozen Breadsticks on a parchment lined sheet pan.
- Bake Breadstick 7–9 minutes. Note: cooking equipment, equipment settings, and kitchen conditions will vary so cooking time may need adjusting. Cook all food thoroughly to 165 °F.
