**Conventional Oven\*:** 1. Preheat oven to 350°F. 2. Place frozen pouches, picture side up, in a single layer on baking sheet. 3. Heat for 18-19 minutes.

**Convection Oven\*:** 1. Preheat oven to 350°F. 2. Place frozen pouches, picture side up, in a single layer on baking sheet. 3. Heat for 13-14 minutes.

\*Do not exceed 350°F. Do not allow pouches to contact any interior oven surfaces. Bake times will vary by oven load and type.
